NOTICE is hereby given that an Extra- Ordinary General Meeting ("EOGM") of the Members of Hardoli Paper Mills Limited (the "Company") will be held on **Thursday, the 13th Day of February, 2020** at 3.30 p.m at Krishna Kunj, First Floor Bhavsar Chowk, C.A. Road, Nagpur - 440002to transact thebusiness mentioned in the Notice convening the said Extra-Ordinary General Meeting.

The Notice convening the EOGM,have been sent electronically to all the members whose email address are registered with their Depository Participant(s) (DP)/RTA. Physical copies of the same have been sent to all other members at their registered address in the permitted mode and it is also available on Company's website at www.hardolipaper.com the dispatch of the Notice of EOGM has been completed on 17th January, 2020.

Further, pursuant to Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended and Regulation 42 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company is pleased to provide its members, the facility to casttheir vote electronically (e-voting) throughe-voting platform provided by Central Depository Services (India) Limited (CDSL) from a place other than the venue of the EOGM ("Remote e-voting").

The Remote e-voting period shall commence **9.00 a.m. on Monday 10thFebruary, 2020 and will close at 5.00 pm on Wednesday 12thFebruary, 2020**(both days inclusive). The Remote e-voting facility will be blocked by CDSL at 5.00 p.m. **on 12thFebruary, 2020**. The cut-off date for determining the eligibility to vote shall be **Thursday, 6th February, 2020**.

The persons whose names are recorded in the Register of Members or in the Register of Beneficial owners maintained by the Depositories as on the cut-off date i.e. 6thFebruary, 2020 only, shall be entitled to avail the facility of remote e-voting or voting through Ballot Paper at the EOGM.

The facility for voting through Ballot paper shall also be made available at the venue of EOGM. Members attending the EOGM, who have not cast their vote by remote e-voting, shall be eligible to exercise their right at the EOGM. However, the Members who have cast their vote by remote e-voting may attend the EOGM but shall not be entitled to cast their vote again at the venue of the EOGM.

Any person, who acquires shares of the Company and becomes member of the Company after the dispatch of the Notice of the EOGM and holds shares as of the cut-off date i.e. 6thFebruary, 2020 may obtain the login ID and password by sending a request at helpdesk.evoting@cdslindia.com. However, if the member is already registered with CDSL for remote e-voting, then he/she can use his/her existing User ID and Password for casting the vote through remote e-voting.
